USE OF LION'S MINIBUS

To comply with DVLA and Insurance conditions we are required to regularly check the intended nature of use, and the Driving Licenses for people using the Lions Minibus.

In order to do this, we require the following information fully completed and returned to us for assessment.

- Application to Drive From (this document)
- Driver Agreement Form
- Copy of both the front and back of your Driving License
- Up to date Print out of your "Share Driving Summary"

Once completed, please return to either to the charity shop (Lions Charity Shop:23 Newburgh Pl, Highworth, Swindon SN6 7DN, Tel: 01793 766800) or email (preferred) it to transport@highworthlions.co.uk.

A print-out of your Share Driving Summary can be obtained from <u>View or share your driving licence information - GOV.UK (www.gov.uk)</u>. This replaces the old paper counterpart to your Licence which gave details of endorsements, etc and is now discontinued. To obtain it you will need (a) your driving Licence Number or your personal details (name, date of birth, gender), (b) your post code, and (c) your National Insurance Number.

After receiving these documents, we will send you an acknowledgement to confirm safe receipt and that your application is being processed. If we require any additional information will contact you using the details provided in this form.

Please be advised that until you receive confirmation from us that your application has been successful, your use of the minibus cannot be permitted.
